Notes:

The preliminary methodology (shown in yellow) counted two individuals per tent and two individuals per vehicle.

On April 27, 2017, the Clean & Safe program adopted the counting methodology used by the Regional Task Force on the Homeless. Per the methodology (represented above by the green cells), Clean & Safe staff counted 1.75 individuals per visible tent/structure and 1.66 individuals per vehicle that showed clear signs of habitation.

In May 2018, the Regional Task Force on the Homeless updated the methodology for vehicles to 2.03 individuals per vehicle that shows clear signs of habitation (the methodology of 1.75 individuals per tent/structure remained the same). The Clean & Safe program implemented this methodology on May 31, 2018 (represented in orange).

* Denotes the months that the Downtown Fellowship of Ministries and Churches collaborated with Clean & Safe on the monthly homeless count.

**East Village breakout areas include the following:

- North East is the area east of Park Avenue & north of Market Street.
- North West is the area west of Park Avenue & north of Market Street.
- South East is the area east of Park Avenue & south of Market Street.
- South West is the area west of Park Avenue & south of Market Street.

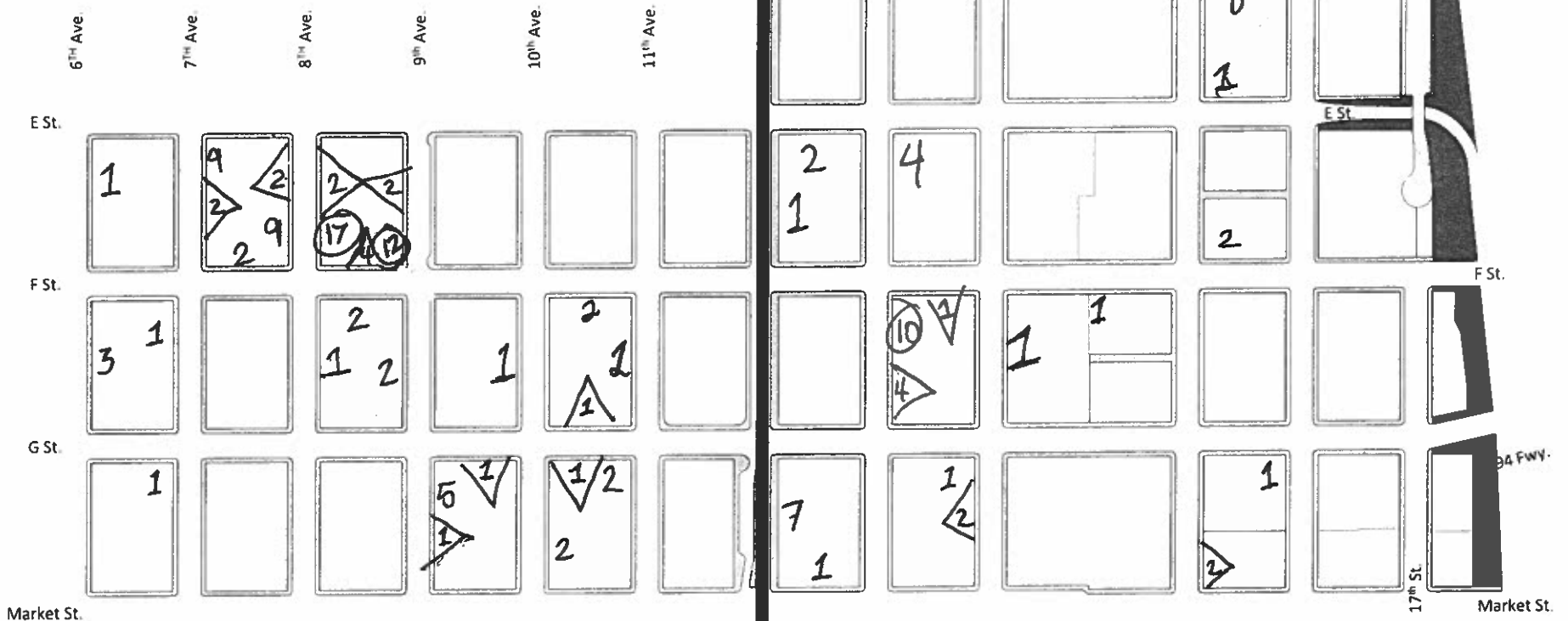
