#### **Liaison Reports**

- Update Provided by MT
- KM: Are you working with the port on pedicab issues?
  - MT: Yes, they are involved
- KM: Where are the arts and culture in the list of priorities?
  - MT: we are going to continue to see how to work with our council for support, tough budget season but it is a priority
- JPS: Comment on pedicabs near the shell
  - o MT: understands they can be disruptive to Downtown as well

### Clean & Safe Update

- LK: Was the b.o.l.o at CVS yesterday?
  - Comment about the individual
  - DG: beware of your surroundings, Downtown is a little tense as of right now
- JPS: Are all these good numbers of unhoused dropping because of the system getting fixed or because of election year?
  - DG: we are conducting case managing, it is a collaborative effort, system is working
  - JPS: seen improvement for sure, seeing a lot of car vandalism in Cortez
    - DG: Seeing the stragglers, SDPD numbers are down with officers, down with dispatcher
  - MO: 6 month period numbers?
    - DG: numbers are definitely increasing, safety overtakes 80% vs. maintenance, supporting SDPD with low priority calls
    - MO: Can't deal with the big groups that don't listen, completely ignore, or get aggressive
      - Question on drug abuse
      - DG: seeing it come in in waves, set the tone with C st, call for backup
      - MO: is your team cleaning the sidewalk in the morning?
        - o DG: have in house team and Aztec
        - MO: did they get their hours cut back?
        - DG: would have to connect you with Ernesto
    - JPS: comment on vacancy tax
    - KM: Is it illegal to have a tank to melt drugs?
      - MT: would have to check
      - DG: issue is prop 47
      - MT: limits the police on what they can do about open drug use, no longer a felony, have to adhere to the state law
      - KM: are there state senators working on that issue?
        - o Malik: Yes
      - KM: should get a representative to talk about that
        - Malik: our office doesn't have a stance but the general idea is that the council member thinks there needs to be some responsible changes
      - KM: comment on recovery with this issue, people won't come back to Downtown if they see that, need some urgency on this

- MT: if it was within the cities jurisdiction, we would do something about it
- KM: comments about worried on investments in Downtown
- KL: When was the prop voted in to?
  - o JH: 2014
  - BF: police liaison has been MIA
  - Clayton: Josh in favor for retail crime restraining orders to help businesses, downtown revitalization, broader conversations
