On April 27, 2017, the Clean & Safe program adopted the counting methodology used by the Regional Task Force on the Homeless. Per the methodology (represented above by the dark gray cells), Clean & Safe staff counted 1.75 individuals per visible tent/structure and 1.66 individuals per vehicle that showed clear signs of habitation.


In May 2018, the Regional Task Force on the Homeless updated the methodology for vehicles to 2.03 that shows clear signs of habitation (the methodology of 1.75 individuals per tent/structure remained the same). The Clean & Safe program implemented this methodology on May 31, 2018 (represented in light blue).


In January 2020, the Regional Task Force on the Homeless stopped using methodology for vehicles and structures, however, the Clean & Safe program continues to use the


